

Minutes of the DeWitt Village Board Regular Meeting held Tuesday, June 4, 2024, at 7:00 PM at the Village Office, 209 E. Fillmore Ave, DeWitt, NE.

The Village Clerk presented to the Village Board an offer from Josi Remmers to clean the Community Center before and after events. She is proposing a monthly fee for the cleaning services rendered with the Village providing the cleaning supplies. After discussion, the Board tabled the issue until the next meeting to discuss further options with Josi Remmers running and maintaining the Community Center, responsibilities and compensation. The Village Clerk presented to the Village Board the amounts for the Village’s health insurance renewal as of July 1, 2024. After review and discussion, the Village Board agreed to stay with the same LIGHT health and dental insurance plans for full-time Village employees and allow the same to automatic renew. Saline County Deputy and Fire Chief, Shawn Weise, informed the Village Board that neither had any issues to discuss with the Village Board. Utility Superintendent, Hunter Oliver, addressed the Village Board regarding the Village pickup trucks and looking into leasing options, breakdowns and repairs at the Wastewater Treatment Plant, culverts in need of repair, NextLink and Diode fiberoptic line updates, timer on lights for basketball court at bus barn, and the bucket truck is now on auction with Purple Wave with the auction ending on June 25, 2024. Village Clerk, Moria Holly, presented her Clerk’s report consisting of sales tax, sanitation service bids on July agenda, and nuisance property update.
