Glen Pieper addressed the Village Board regarding the Civic Board's plans for the Village's 2024 DeWitt Days celebration. The theme is "Salute to the Red, White and Blue" and also discussed the Village's financial support regarding the fireworks display and bounce houses. The Civic Board will present estimates for the fireworks display and bounce house at the June Board Meeting.
